This presentation outlines the new direction PeopleSoft is taking with the World product – they are pumping new life into it with A8.1 Service Pack 6!

Possibly the most important piece of information in this announcement is that there is now a direct path from A8.1 to EnterpriseOne—that's big; it used to be a dead end, and you couldn't get from World A8.1 to EnterpriseOne.

Some clients may want to upgrade from A7.3 to A8.1 cum 6 to get the improved functionality, particularly in Lean Manufacturing. According to the announcements, there are over 250 functionality enhancements, plus some enhancements in the Technical Foundation.
